WAIVER, RELEASE and HOLD-HARMLESS AGREEMENT FOR MINORS

Please read carefully before signing. This is a Release of Liability and Voluntary Waiver of certain legal rights.

As the parent and/or legal guardian of the below named child under the age of 18, I am willfully signing this agreement so the below named minor child has my permission to enter and make use of the INDOOR SHOOTING RANGE AREA. I further agree to indemnify and hold harmless **SHARPSHOOTERS INDOOR RANGE, INC.**, its owners, agents, employees or assigns, from any and all liabilities, claims, demands or causes of action brought by or on behalf of the child named below for injuries and/or damages whatsoever that may arise out of my use of the range, or the child's presence in the range that may be alleged to have been caused by the negligence of **SHARPSHOOTERS INDOOR RANGE, INC.** and or its owners, employees, agents, or assigns or caused by acts of omissions of third parties or caused by hidden, latent, or obvious defects within the range facilities, including but not limited to the bullet trap system and its associated or component parts of the range.

Further, on behalf of the minor child named below, as to whom I am the parent and/or legal guardian, generally and specifically, I hereby forever, generally and specifically release and discharge the **SHARPSHOOTERS INDOOR RANGE, INC.** and / or its owners, employees, agents, or assigns from all liabilities, claim demands or causes of action that the minor child may have against **SHARPSHOOTERS INDOOR RANGE, INC.** and / or its owners, employees, agents, or assigns for any and all injuries or damages arising out of the minor's use of the RANGE FACILITIES or his / her presence at the range including but not limited to injuries or damages caused by (1) the negligence of the RANGE, whether active or passive, and/or its employees, agents, or assigns, or (2) ricochets of bullets or bullet fragments, or (3) the acts or omissions of third parties, or (4) hidden latent or obvious defects in the range facilities including but not limited to, the bullet trap system and associated parts of the range.

I further understand that all minors between the ages of 8 and 12 may only shoot firearms **no larger than .22 caliber** without a **SHARPSHOOTERS INDOOR RANGE SAFETY OFFICER** present in the range with the minor.
